**1. Eligibility Criteria :**

Post Graduate Diploma in Patent Law & Practice / Post Graduate Diploma in Intellectual Property Rights Management

- Graduate with 50% marks from any stream from a recognized University
- Candidates who have completed graduation through distance mode are also eligible to apply

Certificate Course in Drug Regulatory & Intellectual Property Rights

- Graduation in Pharma or Science stream with 50% marks from a recognized University in any discipline.
- Candidates who have completed graduation through distance mode are also eligible to apply

Certificate Course in Intellectual Property

- Candidate should have passed 10 + 2 or equivalent examination.

Note: Candidates who are appearing in 10+2 or equivalent or graduation examination as applicable are not eligible to apply.

Post Graduate Diploma in Patent Law & Practice / Post Graduate Diploma in Intellectual Property Rights Management

- 14 months

Certificate Course in Drug Regulatory & Intellectual Property Rights

- 6 months

Certificate Course in Intellectual Property

- 4 months

#### 6. Fees (subject to revision)

The fees are as follows:

**Post Graduate Diploma in Patent Law & Practice – Rs. 1,50,000/-**

**Post Graduate Diploma in Intellectual Property Rights Management – Rs. 1,00,000/-**

**Certificate Course in Drug Regulatory & Intellectual Property Rights - Rs. 59,000/- (Rs 50,000/- plus 18% GST - Rs 9,000/-).**

**Certificate Course in Intellectual Property - Rs. 41,300/- (Rs. 35000/- plus 18% GST - Rs. 6,300/-).**
